Watering lawns and grass boulevards					<b>Stage 1:</b> One morning per week. Even addresses on Mondays, Odd addresses on Tuesdays. <b>Automatic watering</b> from 4 - 6 am. <b>Manual watering</b> from 6 - 9 am.
Watering new lawns or lawns being treated for the European Chafer Beetle					<b>Stage 1:</b> On any day within permitted times if in compliance with a sprinkling permit.
					<b>Stage 2:</b> Sprinkling permits issued in Stage 1 will remain in effect until permit expires. No new permits will be issued or renewed.
Watering trees, shrubs, and flowers excluding edible plants (Edible plants include vegetable gardens, fruit bearing plants and herbs. Edible plants are exempt from restrictions in Stages 1 to 3.)					<b>Stages 1 &amp; 2:</b> On any day from 4 - 9 am if using a sprinkler or soaker hose and on any day at any time if using a hand-held hose with automatic shut-off device, water container, or drip/micro spray irrigation.
					<b>Stage 3:</b> On any day at any time if using a hand-held hose with automatic shut-off device, water container, or drip/micro spray irrigation. Prohibited if using a sprinkler or soaker hose.
Watering soil-based playing fields					<b>Stage 1 &amp; 2:</b> Soil-based fields may be watered on alternate days between 11 pm - 8 am.
					<b>Stage 3:</b> Soil-based fields may be watered twice a week between 11 pm - 8 am. Watering newly over-seeded fields if in compliance with approved water management plan is allowed.
Watering sand-based playing fields					<b>Stage 1 &amp; 2:</b> Sand-based fields may be watered daily between 11 pm - 8 am.
					<b>Stage 3:</b> Sand-based fields may be watered on alternate days between 11 pm - 8 am. Watering newly over-seeded fields if in compliance with approved water management plan is allowed.
